ORDER:

- 1. The "Sri Padmavathi School of Pharmacy, Mohan Gardens, Vaishnavi Nagar, Tiruchanoor (P), Tirupathi, Chittoor Dist." was given Temporary affiliation for running Degree courses during the academic year 2015-16 vide Procs.(1) read above.
- 2. The AICTE, New Delhi and Government of A.P have accorded extension of approval to the above college for the academic year 2016-17 vide ref (2) and (3) read above. The University has constituted a Fact Finding Committee to verify the staff and infrastructure facilities of the college to consider for grant of Temporary affiliation for the academic year 2016-17 vide Procs. (4) read above. The Fact Finding Committee has visited the college and submitted its report to the University vide (5) read above. The University has constituted a Standing Committee for Affiliation to verify the reports which were submitted by the Fact Finding Committee for the academic year 2016-17. The Standing Committee for Affiliation of the University has verified the reports which were submitted by the Fact Finding Committee and made recommendations for granting Temporary Affiliation for the academic year 2016-17 vide (ref.6) read above.

The Standing Committee for Affiliation has identified the following deficiencies and recommended to rectify the same and submit a compliance report, before 28-11-2016.

- 1. The College should apply for NBA& NAAC accreditation
- 2. At least two governing body meetings are to be conducted in a academic year
- 3. Computer to Student ratio is to be maintained as per AICTE norms
- 4. At least 1 legal system softwares and 10 legal application softwares to be procured
- 5. Library automation software to be procured
- 6. e-journals as per AICTE norms are to be procured
- 7. Faculty cadre ratio is to be maintained as per norms
- 8. Atleast 50% of faculty appointments have to be ratified by the University.
- 9. Internal marks are being given liberally.

10. Aadhaar and PAN number has to obtained by all the teaching staff
