Policy document on providing financial support to teachers for attending conferences/workshops/seminars

Preamble: The policy of giving financial assistance to teachers is in place in order for them to attend conferences and workshops held by reputable national institutions, universities, and colleges, as well as to pay for their membership fees in professional organizations.

Objectives

- 1. To motivate the faculty to present their research papers at reputable national and international conferences.
- 2. To assist the teaching staff in getting the benefit of the opportunity to discuss about breakthroughs, new challenges, and future views in their area of interest.
- 3. To assist the teaching staff in strengthening teaching learning, research extinction activities, and governance by involvement in conferences and seminars.
- 4. To improve their academic performance and meet expectations.

Policy regarding attending of conferences/workshop/seminar

• An employee is permitted to attend the conferences/workshops/seminars at the national level and at the international level. Institute is paying registration fee + TA only. Only employees who have completed research or research-related work are eligible to qualify for R&D policy incentives.

• Registration claims and TA must be dismitted in the required form within one month after attending the conference workshop forminars.
